This Privacy Notice ("Notice") is provided to you, the Donor. and/or recipients of donations on the platform social.sinwattana.com (hereinafter referred to in this announcement as "Processing Activities") has learned and understood the pattern of collection, use and disclosure ("processing") of personal data that Sinwattana Crowdfunding Corporation Co., Ltd. (hereinafter referred to in this announcement, referred to as "Sinwatana" or "we"), acting as a controller of personal data in personal data collected from you for the processing of this processing activity.

Sinwattana Crowdfunding Corporation Company Limited is a platform that provides services in the field of being an intermediary of raising funds. Offering shares outside the market that serve between Individuals or juristic persons who are interested to invest in ordinary shares or preferred shares (Investors) and companies (Limited) registered in Thailand (Issuer). It is under the supervision of the Securities and Exchange Commission (SEC) in accordance with the legal process.

In this regard, we proceed with the collection, use or disclosure of your personal data as follows:

**1. Bases in personal data processing**

We collect your personal information under the following bases:

- 1.1 Comply with the contract.
- 1.2 The necessity for the legitimate interests of us or others.
- 1.3 Consent by collecting, disclosing, using personal data consent required from the owner of personal data, except for exceptions based on other personal data processing bases.

**2. Purpose of collecting your personal data**

We collect your personal data for the following purposes:

- 1.1 To be used to prove personal identity process payment transaction protection incorrect.
- 1.2 for use in communication.

1.3 To be used in the delivery of items in return from supporting the project.

1.4 To be used in the preparation of tax invoices.

#### **4. Disclosure of your personal information**

We disclose your personal information to the following persons or entities:

4.1 Your personal data will be used internally only by financial officers.

4.2 Your personal data will be disclosed to the owners of the Reward program.

#### **5. Your rights under the Personal Data Protection Act B.E. 2562**

Under the Personal Data Protection Act B.E.2562, you have the following rights that you can exercise:

5.1. Right of access: You can obtain a copy of your personal information that we have collected and ask us to disclose the source, unless we have the right to deny your request by law, court order, or if your request may damage the rights and freedoms of others.

5.2. Right to rectification: You can request us to rectify any inaccurate or incomplete personal data to ensure that it is accurate, current, complete, and not misleading.

5.3. Right to request suspension of use: You can request us to suspend the use of your personal data in any of the following cases:

5.3.1. While we verify and correct your personal data to ensure that it is accurate, current, and complete.

5.3.2. When your personal data is collected unlawfully or used or disclosed without your consent.

5.3.3. When your personal data is no longer needed for the purposes as notified but you require us to keep it to enable you to establish, exercise or defend a legal claim.

5.3.4. When we are proving the legitimate grounds for collecting, using, or disclosing your personal data, or verifying the necessity of doing so for public interest, due to your exercise of your right to object to such collection, use, or disclosure.

5.4. Right to object: You have the right to object to the collection, use, or disclosure of your personal data, unless we have legitimate grounds to refuse your request (for example, if we can demonstrate that collecting, using, or disclosing your personal data is necessary to establish legal claims or for public interest according to our mission).

#### **6. Period of retention of personal data**

We will collect your information for the duration of your membership. We retain your personal information for the duration of your membership. And continue to keep for a period of 5-10

years from the date of requesting to cancel the membership both in the case of recipients and donors.

However, after aforementioned period, we will anonymize your personal information for other purposes such as statistical analysis performance improvements or important public interest.

## **7. Personal Data Security**

We have measures to maintain the security of your personal information appropriately. We store your personal data on the RDS database on AWS platform to prevent data loss or have unauthorized access, destruction, use, alteration, alteration, or disclosure of personal data. This is consistent with our Information Security Policy and practices.

Besides, we have established the personal data protection policy published to throughout the organization including the guideline to collect, use and disclose personal data in order to keep confidentiality, integrity and availability of personal data. We will review policies as well as this Notice within the appropriate period.

## **8. Participation of Personal Data Subjects**

At the request of the data subject, their successors, heirs, legal representatives, or guardian, we may disclose personal data. Requests can be made by emailing [dpo@sinwattana.com](mailto:dpo@sinwattana.com).

If the data owner, successor, heir, legal representative, or legal guardian has any objections to the storage, accuracy, or any other actions taken regarding their personal data, we will record the objection as evidence.

However, we may deny this right if required by law or if the personal information is anonymized or unidentifiable.

## **9. Responsibilities of individuals processing personal data**

Only authorized personnel involved in the collection, use, and disclosure of personal data will have access to your information. We ensure that our staff strictly complies with this announcement.
