This Privacy Notice ("Notice") is provided to you, a participant of the Event. Offline and online events of Sinwattana Crowdfunding (hereinafter referred to as the "Activities Processing") know and understand the manner of collecting, using, and disclosing ("processing") data. Individuals at Sinwattana Crowdfunding Corporation Company Limited (hereinafter referred to as "the company Sinwattana Crowdfunding Corporation Co., Ltd. "or "we") operates as a controller of personal data in personal data collected from you for the processing of this processing activity.

4. Disclosure of your personal information

5. Your rights under the Personal Data Protection Act B.E. 2562

Under the Personal Data Protection Act B.E.2562, you have the following rights that you can exercise:

5.1. Right of access: You can obtain a copy of your personal information that we have collected and ask us to disclose the source, unless we have the right to deny your request by law, court order, or if your request may damage the rights and freedoms of others.

- 5.2. Right to rectification: You can request us to rectify any inaccurate or incomplete personal data to ensure that it is accurate, current, complete, and not misleading.
- 5.3. Right to request suspension of use: You can request us to suspend the use of your personal data in any of the following cases:
 - 5.3.1. While we verify and correct your personal data to ensure that it is accurate, current, and complete.
 - 5.3.2. When your personal data is collected unlawfully or used or disclosed without your consent.
 - 5.3.3. When your personal data is no longer needed for the purposes as notified but you require us to keep it to enable you to establish, exercise or defend a legal claim.
 - 5.3.4. When we are proving the legitimate grounds for collecting, using, or disclosing your personal data, or verifying the necessity of doing so for public interest, due to your exercise of your right to object to such collection, use, or disclosure.
- 5.4. Right to object: You have the right to object to the collection, use, or disclosure of your personal data, unless we have legitimate grounds to refuse your request (for example, if we can demonstrate that collecting, using, or disclosing your personal data is necessary to establish legal claims or for public interest according to our mission).

6. Retention period of personal data

We retain your personal data for a period of 3 years from the time we receive the data or until the data subject has an order to destroy or delete the data from the database.

When the period has elapsed, we shall we shall anonymize your Personal Data for proceed some activity such as analytic statistic, operation improvement, important public interest, etc.

7. Data Security

We have measures to maintain the security of your personal information appropriately by means of storing your personal information in Share Point and Mailchimp program to prevent data loss. or have unauthorized access, destruction, use, alteration, alteration, or disclosure of personal data This is consistent with our Information Security Policy and practices.

Besides, we have established the personal data protection policy published to throughout the organization including the guideline to collect, use and disclose personal data in order to keep confidentiality, integrity and availability of personal data. We will review policies as well as this Notice within the appropriate period.

8. Participation of Data Subject

At the request of the data subject, their successors, heirs, legal representatives, or guardian, we may disclose personal data. Requests can be made by emailing dpo@sinwattana.com.

If the data owner, successor, heir, legal representative, or legal guardian has any objections to the storage, accuracy, or any other actions taken regarding their personal data, we will record the objection as evidence.

However, we may deny this right if required by law or if the personal information is anonymized or unidentifiable.

Only authorized personnel involved in the collection, use, and disclosure of personal data will have access to your information. We ensure that our staff strictly complies with this announcement.
